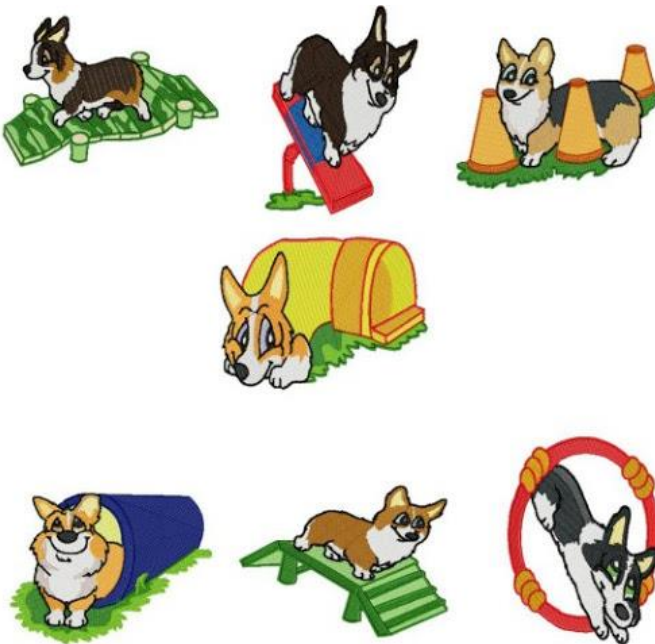

June 16, 2020

Recently the Pasco Kennel Club under the direction of Anna Stromberg and the great volunteers put on a Match allowing exhibitors to be back in the saddle and show our dogs. One judge remarked how well the dogs adjusted to masks in and out of the ring. Of course, purpose bred dogs have sound temperaments!

Many expressed the need for re-opening the dog shows and perhaps contacting the Governor. It appears that our events were not listed as a category. The State did respond to our inquiry, stating we have no restrictions other than what may be mandated under Phase 2 of the Governor's Executive Order 20-139.

We are fortunate in Florida the majority of events cancelled due to COVID-19 have been rescheduled for Conformation, specialty and performance events until the end of the year by each individual club or cluster. Deborah Roberts has informed me Boca Raton has rescheduled to March 2021.

According to Bill Price, the Oklahoma Cluster closed in three hours, entries were limited to 1200, some coming from as far as California and Washington. The next event Mr. Price will be holding is the Sunshine State Cluster, the first re-scheduled dog show in Tampa runs from September 23<sup>rd</sup> through the 27<sup>th</sup>. Bill Price worked tirelessly and stood behind specialty clubs when MBF did not make financial allowances due to COVID cancellations. Onofrio stepped up to the plate to help our clubs and will be the Superintendent. According to Mr. Price this is what you can expect at the indoor Sunshine State Cluster:

There may be limited entries so plan to enter early. He stated his Cluster strongly advises the use of masks and their usage when presenting your dog to the Judge is mandatory. It may be your choice to wear a mask or face shield outside of the ring, but you must maintain social distancing as required by the State of Florida and recommended by the AKC. There will be numerous hand sanitizer stations in the building and chairs will only be available for the Judge and Steward. Specialty Clubs may find limitations on the tables they normally have at ringside and auction tables will not be available. Junior Showmanship will be available and updates will be made on other special events. Mr. Price will have two grooming areas available; one with dryer capability and one without. I think we all will need to practice what we tell our children, and that is to respect others, obey the rules and know that during these exceptional times of COVID, some things may be modified from the Premium list, but the implementation of changes is for the safety of all individuals.

In closing, it's your decision to show your dog, it is your club's choice to put on an event or match. Stay safe, be well and remember to provide the FAKC with updates on your club's events and health clinics. We will provide further updates and recommendations as indicated.
