CLUB PROGRAM

PRESENTED BY Susan Rodgers DVM

Dr. Rodgers presented an open discussion on dog show health problems.

Dog Flu—see doginfluenza.com for tracking map (Merck) Vaccination decreases clinical signs and spread; needs booster to be covered for 1 year; 25% can be asymptomatic carriers

Travel meds for your dogs (for issues that might arise)

Diarrhea: pepto bismol, Imodium, kaopectate (bloody—Clostridium need antibiotic)
REMEMBER TO give antibiotics for 7+ days to prevent resistant bacteria.

Alternatives: Probiotics (before the show) give FortaFLora before the show; if diarrhea, withhold food; bring your own water.

Allergic reactions—give Benadryl 1mg/pound

To Carry in Medication Box
Benadryl, NeoPredef powder for wounds (wet/moist), antibiotics (eg, cephalexin (Keflex) for skin infections 7-10 days; Respiratory antibiotics (eg, doxycycline, minocycline), 22mg/kg;
Pain control like Rimadyl (carprofen), Metacam (meloxicam) one daily; work with vet to get proper medications to carry.
Tylan and metronidazole, active cultures
Topical cleansers like Hibiclens, chlorhexidine
Vet wraps, Telfa pads
